G. Ocean Avenue Association (OAA) - Kate

Kate reported that Philz Coffee will open in the Mercy Housing Building; an Indian/Pakistani restaurant is opening; a juice bar will open soon; Happy Vape has not yet opened; 1325 Ocean is adding apartments; Avenue Bar is negotiating a move from to 1831 Ocean – which was originally a saloon from 1895; playground space in the area is being sought; Target is opening October 25; an application for designation of Ocean Avenue as an arts and entertainment district is in the works; the Japanese karaoke restaurant on Ocean@Granada is aiming to open in January 2016; Unity Plaza will open in 2016.

A. Annual Meeting Debrief

Kate reported that the Annual Meeting was a success and thanked board members for their help. More residents attended this year than in the past; no sandwiches were left over; 17 tables were used for several different organizations and residents; 70 chairs were rented and the new Annual Meeting Committee had great ideas.
