Balboa Reservoir Development Update . . .

WESTWOOD PARK RESIDENTS MEET WITH DEVELOPERS AND WPA BOARD OF DIRECTORS REGARDING PROPOSED DEVELOPMENT

THE WESTWOOD PARK Association Board of Directors called a general meeting of the Westwood Park owners to meet with the board and the developers of the proposed Balboa Reservoir development. Approximately 150 homeowners showed up for the meeting as did representatives of Avalon, Bridge and other members of the joint venture who desires to develop the site with 1,300 or more units. The developers reported that they are in the process of commencing the CEQA (California Environmental Quality Act) process which could take up to two years and seek certification of an Environmental Impact Report from the San Francisco Planning Commission and Board of Supervisors. They also reported that they may consider working with City College to build units on their portion of the reservoir so that the total units on both lots would be increased. Many questions were directed to the developers from property owners. Most owners indicated no opposition to housing but indicated that the density simply would not fit into our historic character neighborhood and reminded the developers that assurances had been given at prior meetings that

Help to Beautify Our Westwood Park Streets

As a designated historic neighborhood, we all want to keep our neighborhood looking good. That includes following local ordinances regarding the placement of garbage receptacles. Residents have noticed that more homes and businesses are not following the city ordinance that requires garbage receptacles must be returned to an enclosed area or other area that blocks views of the receptacles from the public streets. Receptacles may be placed on the street after 6 PM the day before collection day and may remain on the street the day of pickup. Compliance with the City Ordinance will brighten our neighborhood, and also avoid fines from the city. the density of this development would not be much greater than 500 units.

After the developers explained their timeline, they were excused. Mike Ahrens, a board member who represents Westwood Park on the Citizens Advisory Committee, led a discussion and solicited views from the homeowners. While there were different positions on all points, a substantial majority of the homeowners agreed as follows: (a) no development should proceed until alternative parking for City College is arranged to address the 1,500 lost parking spaces; (b) density of the new development should be reduced substantially; (c) no access

should be allowed over the WPA property through San Ramon since residents of the new development would then create even a more difficult parking situation in Westwood Park; (d) the height limitations set forth in the Survey of WPA should not be exceeded; and, (e) parking and traffic issues must also be raised by the Board in the CEQA comment process.

Many good ideas were raised by property owners and the board made notes of all such comments. Since that meeting many property owners have emailed the board. Please continue to email the board with your comments and thoughts on these issues. ♦

2018 Candidate Statements

Michael Ahrens (Incumbent)

I am a third generation native San Franciscan, raised in the Sunset district, attending St. Anne's grammar school, Riordan High School, and USF undergrad and law school. After practicing 48 years as a business bankruptcy lawyer, I fully retired on January 1, 2018. My wife Sandy and I have two children and five grandsons, who are fifth generation natives living in the Bay Area. Sandy and I have lived in Westwood Park since 2000 and love our community.

As I was preparing for retirement I was "drafted" to the Westwood Park Board of Directors in the fall of 2016 to replace a director who had resigned. I have served on the board since the fall of 2016 and have been very active in representing our interests in connection with the proposed development of 1100+ units on the Balboa Reservoir. I have been your representative on the Balboa Citizens Advisory Committee, and have appeared for you before the San Francisco PUC, Board of Supervisors, SF MTA, and other agencies in connection with the proposed development. See feral cats or kittens? Here's what you can do:

Observe: Stand back at least 40-50 feet and observe the area. Is the mother cat with the kittens or nearby? Are the kittens in danger (look for dogs, predators, traffic, exposure to weather)? Note the exact location of the mother cat and kittens, but do not touch them.

Call or Email: Call the San Francisco SPCA Community Cats program at 415-522-3539 or email them at communitycats@sfspca.org with the information you collected. The SF SPCA offers free advice, assistance and sterilization surgery for feral cats and kittens.

Facts about feral cats & kittens: Just because you don't see a mother with the kittens doesn't mean the kittens have been abandoned. The mother may be off for a few hours finding food. Kittens can survive this period without food as long as they are warm.

Kittens have a much better chance of survival when kept with their mother until weaned. The SF SPCA accepts both the mother and her kittens and keeps them together until they are weaned. Kittens will go into the foster program and then on to adoption. The mother will be spayed and returned to where she was found. This prevents new unspayed cats from migrating to the area and breeding. This is the most humane and effective approach to feral cat population control.

Captain Hart has attended Westwood Park SAFE meetings and has been very responsive to inquiries from residents. We look forward to meeting and discussing safety issues with Captain Hart at the annual meeting.
